


Background


- Since Mid 1980s, Market Integration in North America Has Accelerated
 - Exports/Imports
 - Foreign Direct Investment
- Animals & Meat Trade Among Fastest Growing Components
- Discovery of BSE, FMD, Exotic Newcastle, Avian Flu Have All Disrupted Trade
- Market Integration Has Outpaced Regulatory Integration
- Regionalization Allows Trade to Resume






U.S. Meat Exports, 1970-May 2004




U.S. Broiler Prices, 12 Market Avg.



U.S. Imports of Beef and Pork




U.S. Cattle and Hog Imports from Canada






U.S. Broiler Meat Exports, 2003


U.S. Food Food and Kindred Industry Investment in Canada, Mexico, and World Total



European Commission Estimates of BSE Impacts on Beef Use & Prices





Canadian Beef/Cattle Trade Situation

- 60-65% of Beef Production Exported
- 90-95% of Beef Exports to U.S. Market
- Nearly All Cattle Exports to U.S. Market
- Highly Export Dependent, Extremely Dependent on United States
- BSE Having Major Impacts on Canadian Beef/Cattle Industry





Alberta Direct Sale Steer Prices





Canadian Beef Exports to US Market, Jan-Apr 1989-2004






Canadian Cattle Inventory



U.S. Trade Situation

- Meat Trade Fairly Concentrated-Top 3-4 Markets Represent Large Share of Trade
 < 10% of Beef, Pork Exported
 17% of Poultry Meat Exported
- Cattle Trade Limited to North America
- U.S. Imports Feeder Calves from Mexico and Fed Steers from Canada
- U.S. Exports Feeder Calves to Canada
- For Each 1% Decline in Beef Supply, U.S. Cattle Prices Rise 1.6%




US Feeder Cattle Futures, Nov 03-Jan 04



US Fed Cattle Futures, Nov 03-Jan 04




U.S. Beef Production & Demand Index




Omaha Choice Steer Prices




Monthly Omaha Choice Steer Prices \$/100 Pounds



US Cattle Imports from Mexico




US Feeder Cattle Futures, May-Jul 04

Summary


- U.S. Meat Exports Concentrated

Implications

- Degree of Trade Dependence Determines Potential Severity of Animal Disease Impacts
- Maintaining Consumer Confidence Important
