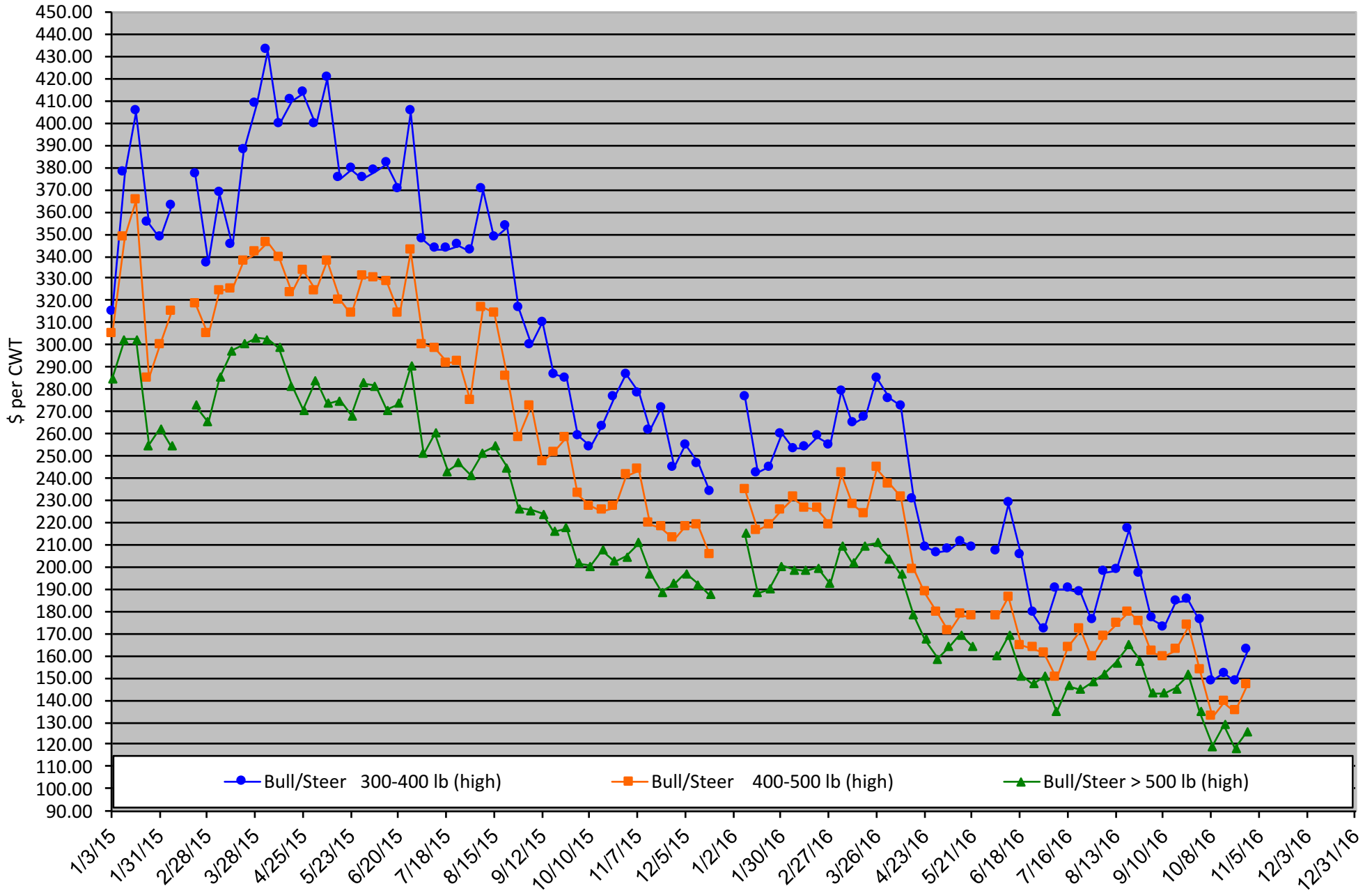

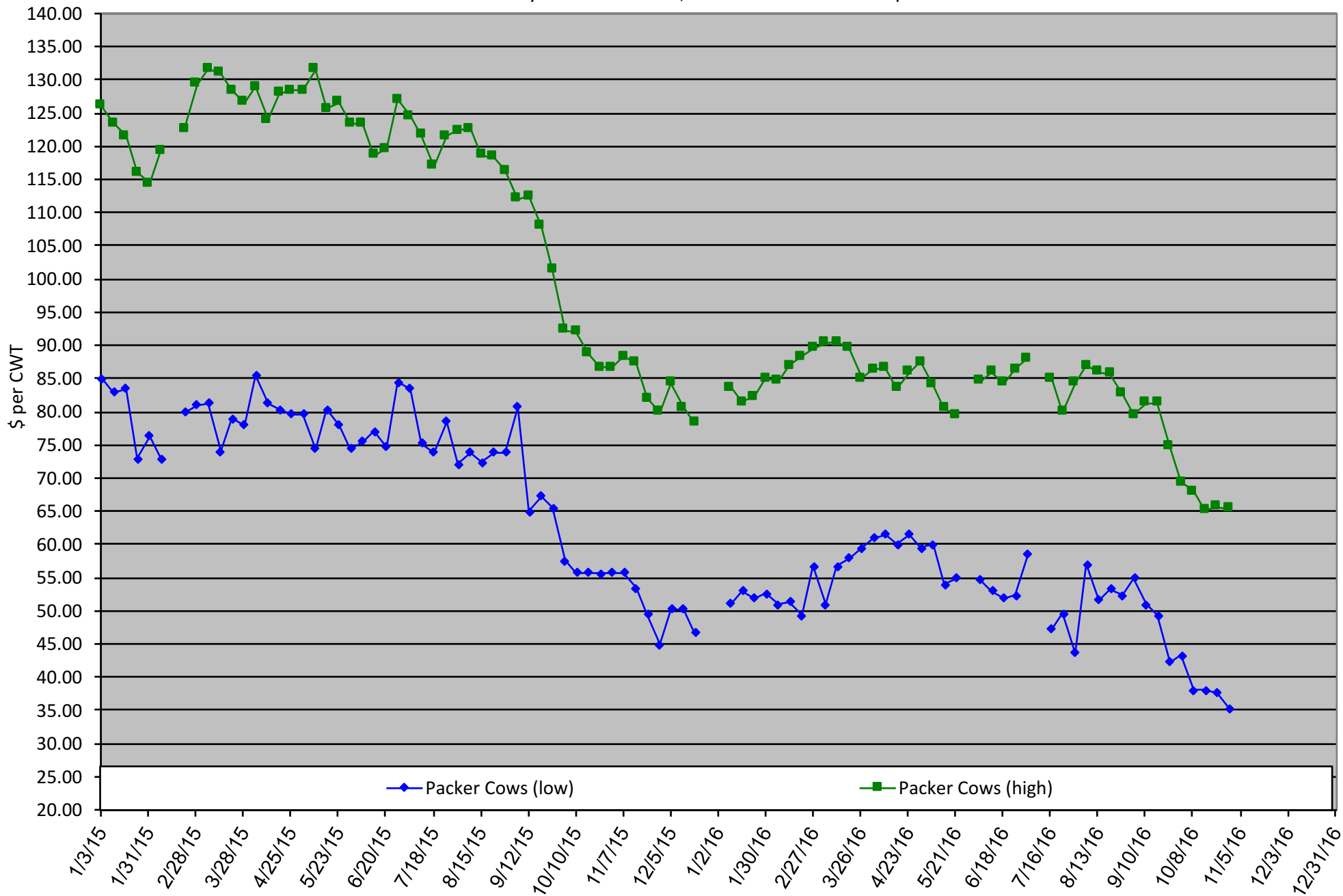


# Packer Cow PriceTrends

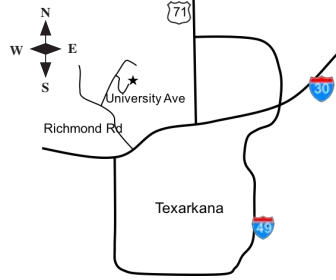

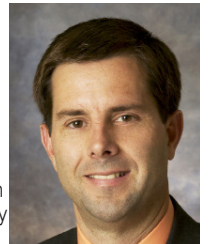
**Brian Triplett**

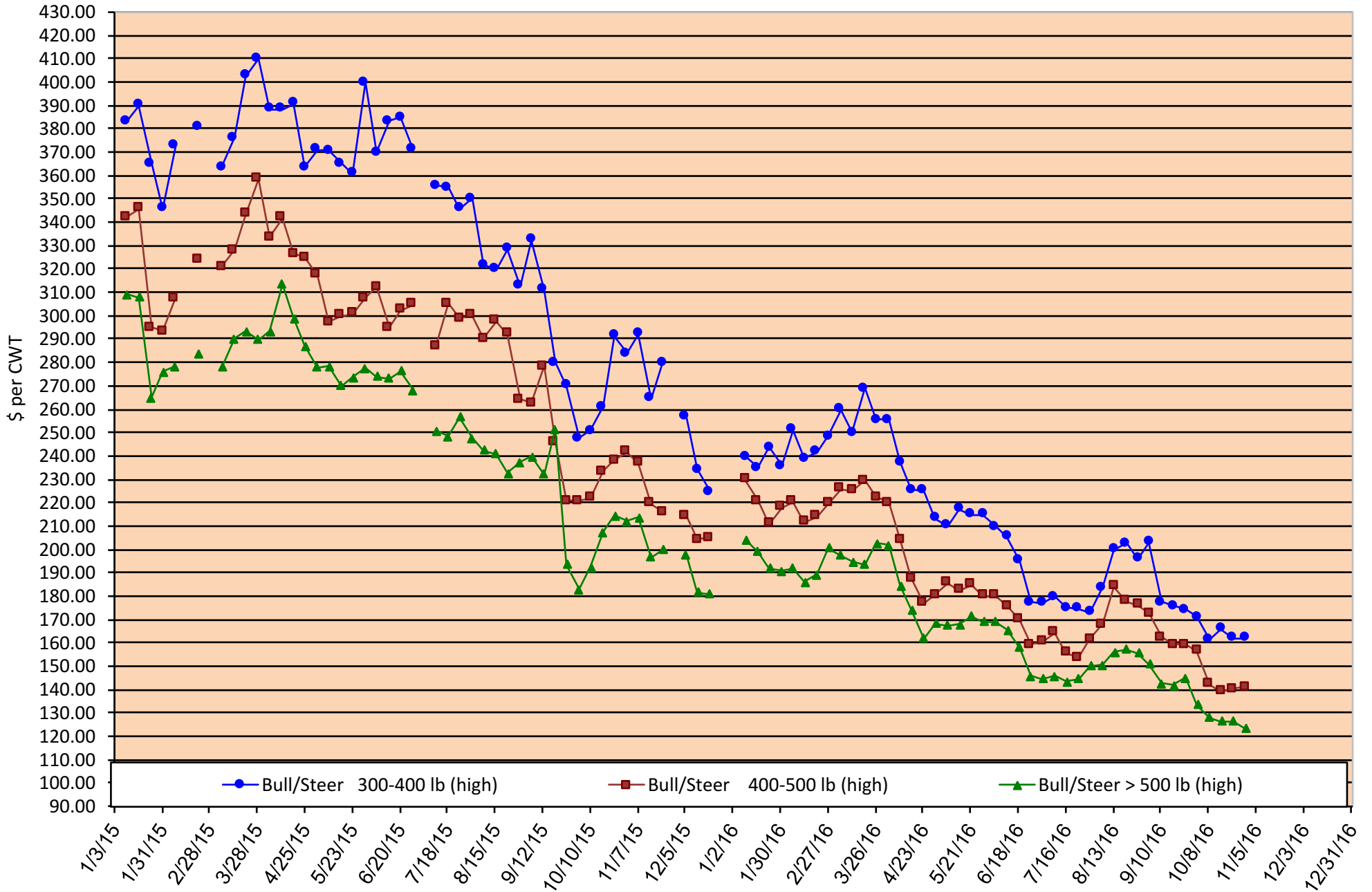
